for admission in September 2023.**

St Paul's, Beechwood, is proposing to reduce its PAN (Planned Admissions Number) from 23 to 18 with effect from September 2023

Consultation period

Consultation will take place for 6 weeks from 12 noon on Friday 17th December 2021 to 12 noon on Friday 28th January 2022.

Consultation details

The Governing Body of St Paul's Catholic Primary School, Beechwood, invite you to take part in the consultation of the admissions arrangements for the school for admissions in September 2023.

Details of the consultation are as follows:

1. Proposal

1.1 It is proposed to reduce St Paul's Catholic Primary School's Pupil Admission Number (PAN) to 18 to reflect local pupil demand.

1.2 Reducing the PAN will assist the Governing Body in providing stability to their long-term planning while continuing to provide an appropriate number of places for future pupils living in the surrounding area.

1.3 Reducing the PAN better reflects the capacity of the school building

3. Rationale

3.1 The current PAN is higher than local demand for Catholic school places and too high for the capacity of the school building. Reducing the PAN will reflect need.

3.2 The purpose of the proposed reduction is to bring the admission capacity more in line with the actual number of pupil intake and the capacity of the school building.

3.3 The reduced PAN will enable the school to ensure continued financial sustainability and allow the school to deploy its resources efficiently.

The consultation closes at 12 noon on Friday 28th January 2022.

Responding to the consultation

Any responses received after noon on 28th January 2022 will not be considered during the determination of the final decision.
